Our engagement included carrying out limited procedures for obtaining sufficient appropriate evidence to be able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting matters and other procedures we considered necessary.

1. GENERAL

The Public Fund-Raising Activity is an event organized by AnAn International Education Foundation Hong Kong (Charity) Limited "The Foundation", which is for the purpose of raising funds for talks on autism for the public, training of Instructors and publications.

The Foundation is an approved charitable institution under Section 88 of the Inland Revenue Ordinance.

2. PRINCIPAL ACCOUNTING POLICIES
